## Public Measure OQ

SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

Summary: To authorize imposition of a local sales and services tax in the unincorporated area of the County of Marion, at the rate of one percent (1%) to be effective on January 1, 2024.

A local sales and services tax shall be imposed in the unincorporated area of the County of Marion, at the rate of one percent (1%) to be effective on January 1, 2024. Revenues from the sales and services tax shall be allocated as follows: Fifty (50%) for property tax relief. The specific purposes for which the revenues shall otherwise be expended are: Fifty percent (50%) for community betterment projects or other lawful purposes of the County of Marion, lowa.

SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

Shall the Board of Directors of the Pella Community School District in the Counties of Marion, Mahaska and Jasper, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$40,000,000 to provide funds to construct, furnish, and equip an Early Childhood Center and improve the site; to construct, furnish, and equip a classroom addition that connects Jefferson Intermediate and the Middle School buildings and to remodel, repair, improve, furnish and equip portions of Jefferson Intermediate and the Middle School buildings, and improve the parking; to improve and replace the HVAC system in the High School building, including the gymnasiums; and to improve, remodel, and repair the athletic stadium and baseball/softball fields and to improve those sites; and to construct new tennis courts?
