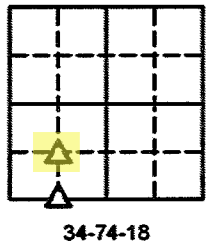
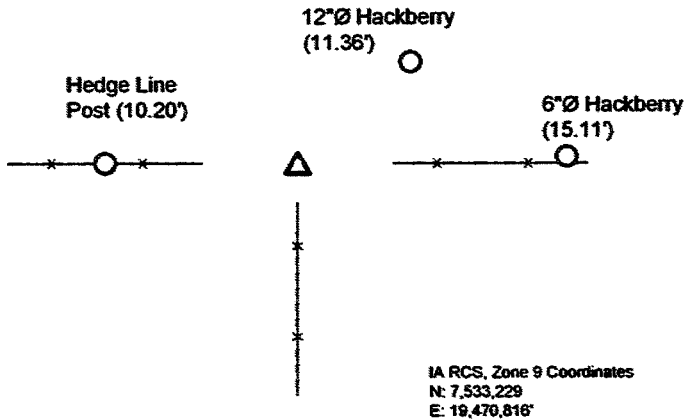

Set 1/2" iron pin with purple cap at the intersection of an East - West fence with a fence from the South.

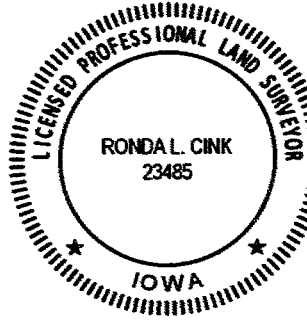
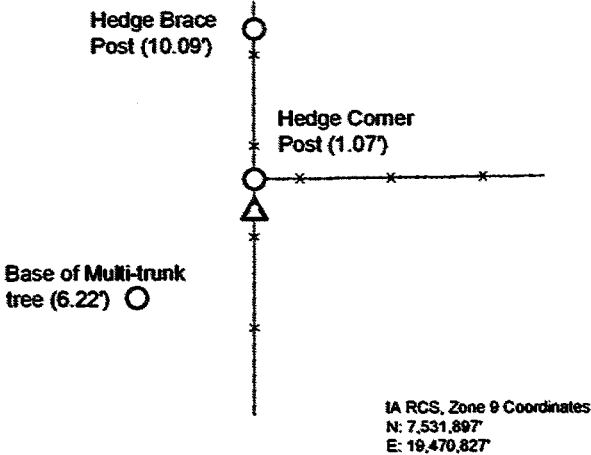
