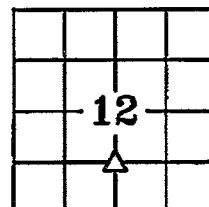
MONUMENT DESCRIPTION & REMARKS

No certificate of record. This corner was used for a retracement plat of survey in the SW 1/4 of the SE 1/4 of Sec. 12.

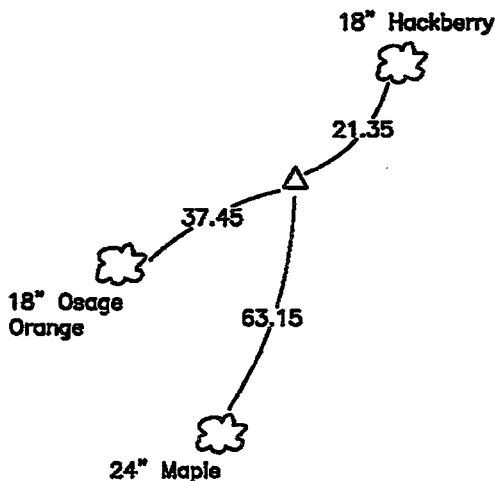
PLAN VIEW
