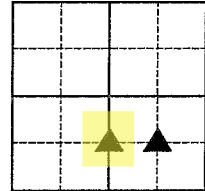

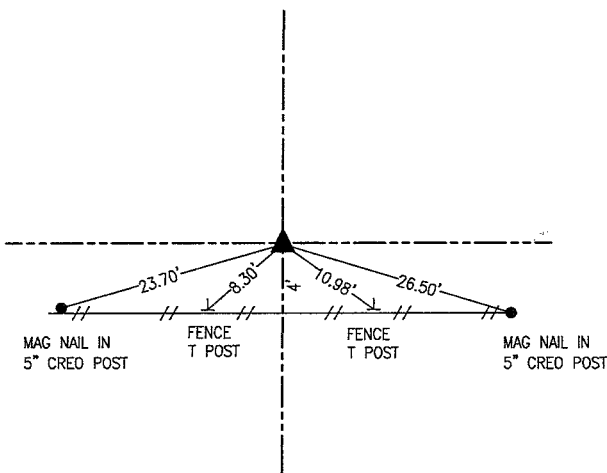

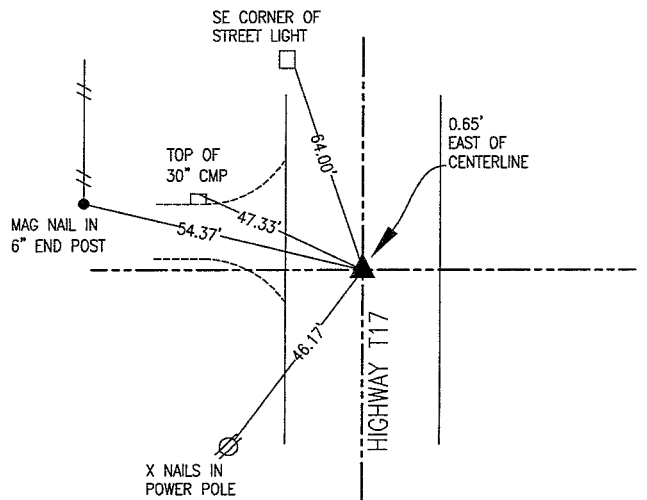

DID NOT FIND ANY RECORDS OF THIS CORNER WITH THE RECORDER OR COUNTY ENGINEER.

LS 6708 USED A MIDPOINT SPLIT BETWEEN SOUTH 1/4 AND CENTER OF SECTION TO CALCULATE QUARTER-QUARTER CORNERS TO THE WEST AS SHOWN ON THE PLAT OF SURVEY RECORDED IN BOOK 229 ON PAGE 450. HE SHOWED THE LOCATION OF THE FENCE ON HIS PLAT. THE EAST-WEST FENCE STARTS AT THE FENCE CORNER AT THE NW CORNER OF THE SW-SW AND THEN ANGLES SOUTHEASTERLY FOR A 1/4 MILE AND THEN RUNS EASTERLY APPROXIMATELY PARALLEL WITH AND 20 FEET SOUTH OF HIS SURVEYED 1/4-1/4 LINE TO THE LOCATION OF THE CALCULATED MIDPOINT SPLIT. THE FENCE THEN CONTINUES THE SAME COURSE FOR ANOTHER 1/2 MILE EASTERLY TO HIGHWAY T17.

DECIDED THE MIDPOINT SPLIT CALCULATED BY LS 6708 BUT NOT MONUMENTED IN 1992 WAS TOO FAR NORTH IN RELATION TO LOCAL EVIDENCE SUCH AS THE FENCES AND LAND USE. SHOT THE FENCE RUNNING THE NORTH LINE OF THE SE-SE OF 15-76-18 ON THE EAST SIDE OF T-17. EXTENDED THAT LINE WESTERLY TO A LINE CONNECTING THE SOUTH 1/4 AND CENTER OF SECTION AND SET A 5/8" X 30" REBAR WITH CAP #19960

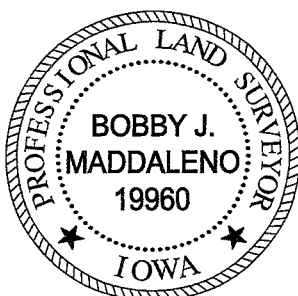
SET MAG NAIL ON LINE BETWEEN NE CORNER OF THE NW-SE AND THE SE CORNER OF THE SW-SE IN LINE WITH FENCE TO THE EAST. THIS POSITION MATCHED EXISTING FIELD ENTRANCES BETTER THAN A THEORETICAL MID-POINT SPLIT.
