



SEARCHED IN THE VICINITY OF THE CORNER BUT DID NOT FIND A MONUMENT. THE SOUTH 1/4 HAS BEEN OBLITERATED BY EROSION FROM A DRAINAGE DITCH. EXISTING ROADS ARE BEST EVIDENCE OF CORNER LOCATION. SET 5/8" X 30" REBAR WITH YELLOW CAP #19960 AT ROAD P.I.



AUGUST 2023
SEARCHED IN THE VICINITY OF THE CORNER BUT DID NOT FIND A MONUMENT. CALCULATED A POSITION FOR THE E 1/4 USING TWO REMAINING WPA TIES. CALCULATED THE MIDPOINT BETWEEN EAST 1/4 AND CENTER. THIS POSITION LINES UP WITH FENCE SOUTH AND APPROXIMATELY 1.5' SOUTH OF ROAD CL. SET 5/8" X 30" REBAR WITH YELLOW CAP #19960 AT THAT LOCATION.

FOUND 1-1/2" PIPE APPROXIMATELY 5 FEET NORTH AND 6 FEET WEST OF AN EXISTING END POST BUILT NEXT TO AN ANCIENT FENCE CORNER. CONTACTED THE ARMY CORPS OF ENGINEERS AND WAS PROVIDED MAPS AND NOTES CONFIRMING THE PIPE WAS SET BY THE CORPS. IT DOES APPEAR THE CORP SET IT ON LINE BETWEEN THE SE AND SW CORNER OF SEC. 17-77-20. ALTHOUGH THE PIPE DOESN'T FIT THE LOCAL EVIDENCE, DECIDED TO HOLD IT SINCE IT WAS SET BY A GOVERNMENT SURVEYOR.
