10. McCombs moved and Jahner seconded to approve Resolution 2021-16 Acceptance of Right-of-Way for Maintenance in Eagle Creek Subdivision as follows:

Whereas, Eagle Creek subdivision plats 1 and 2 were approved June 10, 1996 and January 26, 1998, respectively and;

Whereas, 202nd Ave., 203rd Pl, 204th Pl. and 205th Pl. and related appurtenances were constructed and complied with the county's standards and were for road maintenance, including snow removal, to the shoulder of the road per the County Engineer effective on November 1, 1996, March 17, 1998, August 17, 1998, respectively;

Whereas, letters to the developer stating the above also stated the right-of-way beyond the shoulder of the road would not be accepted for maintenance by Marion County until it was brought up the required standard;

Whereas, more than two decades have passed and Marion County as not maintained the right-of-way beyond the shoulder/pavement edge to the extent in which it is impacting the preservation of the pavement and the subgrade beneath the pavement;

Whereas, the Road Department is planning to invest significant funds to preserve the integrity of the pavement within Eagle Creek and in the interest in preserving that investment, doing due diligence and to formalize the County's roles, the County Engineer recommends the Board accept the right-of-way in its entirety for maintenance;

Now Therefore Be It Resolved that the entire right-of-way in Plats 1 and 2 of Eagle Creek Subdivision, in its current state, be accepted for maintenance into the Marion County Road system.
